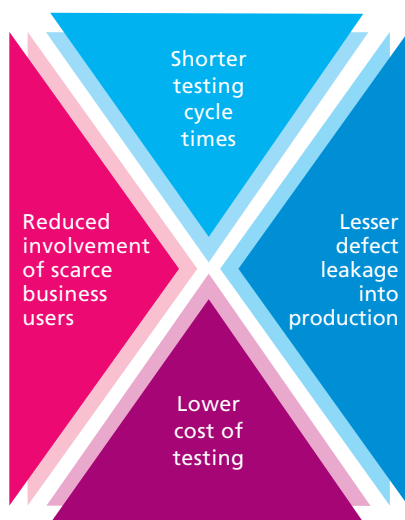

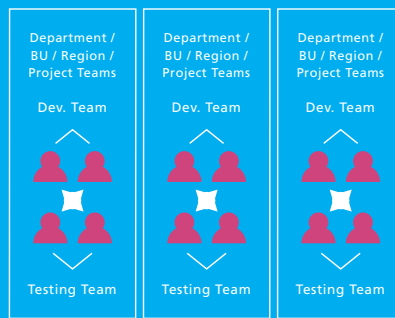

Decentralized Testing - Drawbacks

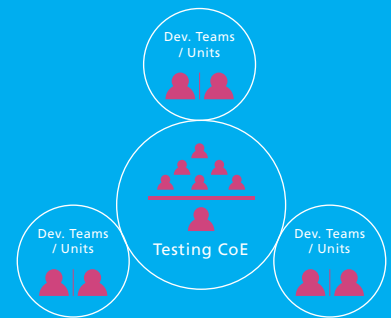


- Distributed testing teams
